Also, my family loves to ride our bikes around but with younger kids it can be challenging with the amount of street traffic on the roads (Laurel/ Elm) that feed into the downtown space. How can we make San Carlos a more bike and pedestrian friendly town? Narrow roads and the number of cars parked on the street are a big hurdle, but solutions like some seen in SF with resident/bike/pedestrian traffic only streets could be explored.

Also, the larger construction projects that I have noticed recently seem to be a combination of retail and condos what additional concessions could developers offer for lessees who invest in building out these new retail spaces?
