**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CARLOS
ENDORING THE REFINED STREET DESIGNS FOR THE DOWNTOWN SPECIFIC PLAN
AND STREETScape MASTER PLAN PROJECT.**

WHEREAS, the City Council of the City of San Carlos has made the planning for the future of its downtown one of its top strategic objectives, as originally set forth in the City’s adopted 2021 Strategic Plan, and reaffirmed this during its City Council retreats on January 21, 2022, January 27, 2023, and January 18, 2024; and

WHEREAS, following extensive civic engagement between May 2023 and March 2024, the Downtown Advisory Committee (“DTAC”) endorsed a preferred street design as part of the Downtown Specific Plan and Streetscape Master Plan project during its meeting of March 19, 2024; and

WHEREAS, following input from the Planning and Transportation Commission on May 20, 2024, the DTAC’s recommended street design was presented to the City Council on June 10, 2024, for its review and following receipt of public comments; and

WHEREAS, on June 10, 2024, the City Council provided input to staff and adopted Resolution 2024-067 affirming the street designs for testing and modeling of traffic and parking outcomes; and

WHEREAS, on August 28, 2024, refinements to street designs and key findings from traffic and parking studies were presented to the downtown business community for review and input; and

WHEREAS, on September 3, 2024, refinements to street designs and key findings from traffic and parking studies were presented to the Downtown Advisory Committee, Economic Development Advisory Commission, Parks Recreation and Culture Commission, Planning and Transportation Commission, and the Youth Advisory Council during an All-Commissions Special Joint Meeting.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of San Carlos endorses the refined street designs for the Downtown Specific Plan and Streetscape Master Plan Project.
