

**RESOLUTION NO. 2024 – \_\_\_\_\_**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CARLOS  
APPROVING THE RECOMMENDATIONS OF THE  
CITY CENTENNIAL ADVISORY COMMITTEE.**

**WHEREAS**, the City Council appropriated \$250,000 in Fiscal Year (“FY”) 2023-24 and \$750,000 in the FY 2024-25 for the Capital Improvement Program Budget for Project #C2309 City of San Carlos Centennial Celebration; and

**WHEREAS**, the City Council appointed a City Centennial Committee (“Committee”) to bring a group of residents and community members together to share ideas on ways the City can celebrate its one hundredth anniversary of incorporation; and

**WHEREAS**, the Committee held its first meeting on January 17, 2024 at which City staff introduced the purpose, expectations, and goals of the Committee and each member was sworn into office by the City Clerk; and

**WHEREAS**, at the second meeting held on February 21, 2024, staff facilitated a more thorough brainstorming session with both primary and alternate Committee members to cultivate a list of activities and celebrations for the centennial; and

**WHEREAS**, the Committee voted 14-7 in favor of hosting the centennial community event in conjunction with the annual Hometown Days weekend (third weekend in May); and

**WHEREAS**, the top three projects voted on include:

- A project with StoryCorps to produce and audio/visual keepsake for long-term display that will commemorate the history of San Carlos with personal stories from community members. StoryCorps will facilitate, record, edit, and design these videos for the City to share during the centennial.
- Development of a map of San Carlos historical markers to be shared with the community.
- Compilation of an oral update to the book, *San Carlos Stories: An Oral History for the City of Good Living*, by Linda Garvey; and

**WHEREAS**, the Committee voted 19-2 to recommend that the City Council consider naming the 700 block of Laurel Street “Centennial Plaza”; and

**WHEREAS**, the Committee voted to recommend three updated and new logos to use throughout the Centennial year including the City Seal, Good Living Logo and a Centennial logo.

**NOW, THEREFORE BE IT RESOLVED**, that the San Carlos City Council hereby approves the aforementioned recommendations of the City Centennial Advisory Committee.
