**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN CARLOS  
APPROPRIATING \$100,000 FROM THE GENERAL CAPITAL FUND TO THE CITY  
FACILITIES CAMERAS PROJECT C2205 IN FISCAL YEAR 2022-23, AUTHORIZING THE  
CITY MANAGER TO EXECUTE THE CITY FACILITIES CAMERAS PRODUCTS AND/OR  
SERVICES AGREEMENT WITH EDGEWORTH SECURITY, LLC IN THE AMOUNT OF  
\$443,573, AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH TPX  
COMMUNICATIONS FOR INTERNET SERVICES TO SUPPORT THE CAMERA SYSTEM  
WITH AN OPTION TO RENEW ANNUALLY AND/OR ADJUST PRICING TO MODIFY  
INTERNET SPEEDS IF NEEDED TO SUPPORT THE CAMERA SYSTEM, AND  
AUTHORIZING AN EXPENDITURE OF CONTINGENCY IN THE AMOUNT OF \$77,984.**

**WHEREAS**, in 2018, the City installed surveillance cameras at the Youth Center and Burton Park to enhance safety and security in our parks and facilities, which has facilitated in solving crimes in Burton Park; and

**WHEREAS**, the City and the San Mateo County Sheriff's Office continue to discover and address graffiti, vandalism, and other crimes in other public parks and facilities; and

**WHEREAS**, a request for proposals from qualified firms who specialize in installation of surveillance cameras was posted on the City's website on June 8, 2022; and

**WHEREAS**, six firms responded with proposals by the deadline and each firm was ranked based on set criteria for the project; and

**WHEREAS**, the two highest ranked firms were invited for an interview; and

**WHEREAS**, during its interview, Edgeworth Security demonstrated its thorough knowledge and expertise working with municipalities on security projects, as well as work prior in San Carlos for the installation of the security cameras at the Youth Center and Burton Park in 2018; and

**WHEREAS**, internet service at all sites are necessary for video surveillance and video retention; and

**WHEREAS**, TPx Communications provided the lowest quote for internet services for a three-year contract, with option to renew annually; and

**WHEREAS**, it might become necessary to adjust/modify the pricing with TPx Communications to modify internet speeds to support the system once implemented; and

**WHEREAS**, funding in the amount of \$450,000 was allocated in Fiscal Year ("FY") 2022-23 for the City Facilities Camera Project C2205 ("Project"); and

**WHEREAS**, staff recommends authorizing the additional appropriation of \$100,000 from the General Capital Fund ("Fund 25") to the Project budget for FY 2022-23 in order to award the Project agreements with contingencies.

**NOW, THEREFORE BE IT RESOLVED**, that the San Carlos City Council hereby appropriates \$100,000 from the Fund 25 to the City Facilities Camera Project C2205 in FY 2022-23; authorizes the City Manager to execute a Products and/or Services Agreement with Edgeworth Security, LLC, in the amount of \$443,573; authorizes the City Manager to execute an agreement with TPx Communications for internet services to support the camera system with the option to renew annually and/or adjust pricing to modify internet speeds if needed; and authorizes an expenditure of contingency in the amount of \$77,984.
