1. CALL TO ORDER

Mayor Dugan called the meeting to order at 7:00 PM.

5. PRESENTATIONS

- a. Recognize Mr. Marty De and Students Alina Robinson, Calvin Massey, Neilson Chien and Talia Simon from the Tierra Linda Middle School Debate Team Upon Winning the World Schools Debating Championship.

Mayor Dugan recognized the Tierra Linda Middle School Debate Team for winning the World Schools Debating Championship. He presented Marty De with a City Coin and a proclamation to each of the students.

Mr. De thanked the City for the recognition and the San Carlos School District and coaches for their support.

Students Alina Robinson, Calvin Massey, Neilson Chien and Talia Simon each spoke on what they learned from their experience with the speech and debate team.

6. COUNCIL COMMUNICATIONS AND ANNOUNCEMENTS

Councilmember Rak reported on attending the Fire Station 16 Ribbon cutting and recognized the Public Works team and other city staff for their work on the project.

Vice Mayor McDowell commended City staff on the completion of Fire Station 16. She also encouraged the community to take the Transportation Authority survey available now on the City's website.

Councilmember Venkatesh reported on filing errors she made in her 2022 committee campaign statements. She provided details on the inadvertent omissions and apologized for her oversight.

Mayor Dugan noted that a member of the community reported a potential violation on this matter, but he will wait for the Fair Political Practices Commission's investigation report before making a determination on the alleged violation.

Councilmember Collins spoke on a community members' allegations made against him as a potential Code of Conduct violation.

Mayor Dugan noted that after consulting with the City Attorney, he believes that there is no violation from Councilmember Collins, and no further action will be pursued.

Adam Taub, resident, requested Council to explore options regulating political messages on billboards.

Mayor Dugan and City Attorney Greg Rubens responded to the public comment.
